Processing of personal data in connection with joining the association

In case of corresponding insurance cases, the data will also be passed on to the club accident insurance.

The written communication to the member is carried out by the association exclusively by e-mail (see statutes).

This includes not only the invitation to the general meeting and in case of questions about the administration of the membership and organization of the game and training operations, but also regular information about club matters.

3. As a rule, the processing of personal data is carried out on the basis of necessity for the fulfillment of a contract (pursuant to Article 6 para. 1 lit. b) DSGVO). The contractual relationship is primarily the membership relationship in the association. Personal data is used for the organization of the membership (esp. Invitation to meetings, communication from the club [incl. responsible trainers] to the member, collection of dues, organization of training and sports operations) and for participation in games. Personal data will be forwarded to the respective state professional associations for participation in competitions, tournaments and games.

Personal data of the members will be forwarded to the respective state professional association for the acquisition and extension of a license, scorecard, player pass, referee pass and referee pass or other participation authorization. The data of the bank details of the members will be forwarded to the current credit institution of the club for the purpose of collecting the membership fee.

The publication of personal data on the Internet or in local, regional or national print media (and online editions of the same) is done to protect the legitimate interests of the association (see Article 6 (1) f) DSGVO).

The legitimate interest of the association is to inform the public by reporting on the activities of the association. activities of the association. In this context, personal data, including images of teams and scenes from matches/competitions, of participants are published, for example, as part of the presentation of teams and reporting on sporting events of the club on the homepage and in the social media of the club, on pages of professional associations and print and online media of the press. If personal data are collected without the processing being necessary for the performance of the contract, the processing shall be based on consent pursuant to Article 6 (1) a) in conjunction with Article 7 DSGVO.

4. The personal data will be stored for the duration of the membership. Upon termination of membership, the data will be retained by different legal retention periods for a maximum of eleven years and then deleted. In the period between termination of membership and deletion, the processing of this data is restricted. Certain categories of data are stored for the purpose of creating/maintaining the association chronicle beyond the above period. These are the categories first name, last name, date of birth, membership in the club and a team, special sporting successes or events in which the person concerned has participated. The storage is based on a legitimate interest of the club in the contemporary documentation of sporting events and successes and the respective composition of the teams / sections and the development of the club.

5. The person shall be entitled to the following rights under the conditions specified in each of the articles.

- the right to information according to Article 15 DSGVO,
- the right to rectification in accordance with Article 16 DSGVO,
- the right to erasure pursuant to Article 17 DSGVO,
- the right to restriction of processing according to Article 18 DSGVO,
- the right to data portability according to Article 20 DSGVO,
- the right of objection according to Article 21 DSGVO,
- the right to lodge a complaint with a supervisory authority pursuant to Article 77 of the GDPR
- the right to revoke consent given at any time, without affecting the lawfulness of the processing carried out on the basis of the consent until the revocation is affected by this.
